In consideration for Bent Tree Community, Inc. ("BTCI") and K-COMP Consulting, Inc. (KCI) allowing my minor child to participate in handling horses, horseback riding and other summer camp activities, the undersigned, on behalf of myself, my child or our personal representatives, heirs, next- of-kin, spouses and assigns, HEREBY AGREE TO THE FOLLOWING:

1. I acknowledge that horseback riding is an inherently dangerous activity which involves risks that may cause serious injury and in some cases death. I further understand that an animal, irrespective of its training and usual past behavior and characteristics, may react unpredictable at times based upon instinct or fright which is an inherent risk to be assumed by each participant in the riding activity.
2. I voluntarily assume all of the risk and danger of injury or death inherent in the handling or riding of horses and use of equipment provided by BTCI / KCI.
3. I understand that Bent Tree requires that all minors wear a secured ASTM/SEI Equestrian standard certified helmet at all times while riding horses. I realize that no form of preplanning can remove all of the dangers while involved in this activity.
4. I acknowledge under Georgia Law an equine activity sponsor or equine professional is not liable for any injury to, or the death of a participant in equine activities resulting from the inherent risks of equine activities, pursuant to Chapter 12 of Title 4 of the Official Code of Georgia Annotated.
5. I agree to release, acquit and forever discharge BTCI, KCI, its directors, officers, their employees and agents from any and all liability, claims for damages, causes of action, demands, costs, and expenses, for injury or damage, either personal or property, arising from or related to my (or my minor child's) participation in handling horses, horseback riding or other summer camp activity; and use of BTCI's / KCI's property.
6. I agree to indemnify, defend and hold harmless BTCI, KCI, its directors, officers, their employees and agents from any and all claims, demands, and causes of action, including court costs and actual attorney fees and costs, which occur or arise as a result of any claim of injury or loss suffered by me (or my minor child) arising from or related to participation in handling horses, horseback riding or other summer camp activity; and use of BTCI's / KCI's property.

I HAVE READ THIS DOCUMENT AND UNDERSTAND IT. I AM AWARE THAT BY SIGNING I AM WAIVING CERTAIN LEGAL RIGHTS I MAY HAVE AGAINST BTCI / KCI. I HAVE MADE A FREE AND DELIBERATE CHOICE TO SIGN IT AS A CONDITION TO BTCI / KCI ALLOWING ME OR MY CHILD TO RIDE OR HANDLE A HORSE.
